The subject of the contract is the supply of a specialized vehicle for collection and disposal of waste for short distances, a multifunctional vehicle for street cleaning of small garbage, waste containers and small composting units for the waste management needs of the Municipality of Kula.

### **7.1. Lot N 1 “Supply of a specialized vehicle for collection and disposal of waste for short distances and a multifunctional vehicle for street cleaning of small garbage”.**

The lot includes supply of a specialized vehicle for collection and disposal of waste for short distances and a multifunctional vehicle for street cleaning of small garbage.

### **7.2. Lot N 2 “Supply of waste containers and small composting units”.**

The lot includes supply of 250 waste containers (110 Ltr), 50 waste containers (1100 Ltr) and 25 small composting units (min 600 Ltr).

**9.1.** The estimated contract value is EUR 200 075 excl. VAT divided in lots as follows:

- for Lot N 1 : EUR 179 400 excl. VAT;
- for Lot N 2 : EUR 20 675 excl. VAT.

**9.2.** The implementation period shall be up to 20 days from the date of the supply contract signing as the Contracting Authority needs to ensure the continuity of waste management services in the municipality.

**9.3.** The place of delivery and acceptance shall be the Municipality of Kula, town of Kula, Republic of Bulgaria.

**9.4.** The contractor shall be obliged to conduct induction training on operation of the supplied equipment and devices / machines.
