<p>According to the information on page 10 of the Instructions to tenders you state that “<i>Technical and professional capacity of candidate: ...It must have completed at least 2 (two) projects of the same nature as the works concerned by the tender and implemented during the following period: 28.04.2009 ÷ 28.04.2017. For projects of similar nature comparable to the works concerned will be accepted works for repair and/or reconstruction and/or restoration and/or conservation of original and/or stone walls of immovable cultural heritage / monuments of culture. The Contracting Authority reserves the right to ask for copies of certificates of final acceptance signed by the supervisors / contracting authority of the projects concerned</i>”.</p> <p>At the same time concerning the content of the tenders on Page 9 of the Instructions to tenders you state that: “<i>All tenders must comprise the following information and duly completed documents: ...evidence of relevant experience in</i></p>	<p>In point <u>16.b Technical and professional capacity of candidate</u> of the Contract Notice is stated that the tenderer <i>must have completed at least 2 (two) projects of the same nature as the works <b>concerned</b> by the tender and implemented during the following period: 28.04.2009 ÷ 28.04.2017. For projects of similar nature comparable to the works concerned will be accepted works for repair and/or reconstruction and/or restoration and/or conservation of original and/or stone walls of immovable cultural heritage / monuments of culture. The Contracting Authority reserves the right to ask for copies of certificates of final acceptance signed by the supervisors/contracting authority of the projects concerned.</i></p> <p>The same criterion is stated in the Instructions to tenders on page 10 <i>Technical and professional capacity of candidate: ...It must have completed at least 2 (two) projects of the same nature as the works concerned by the tender</i></p>

*carrying out works of a similar nature, including the nature and value of the contracts, works in hand and contractually committed (Form 4.6.4). The evidence must include successful experience as the prime contractor in construction of at least 1 /one/ project of the same nature and complexity comparable to the works concerned by the tender during the last eight years”*

In relation to the above we would like to ask the following:

1. How many projects of the same nature as the works concerned by the tender and implemented during the following period: 28.04.2009 ÷ 28.04.2017, should the participant have completed; and
2. Evidence for how many projects of the same nature as the works concerned by the tender and implemented during the following period: 28.04.2009 ÷ 28.04.2017, should the participant present with the tender.

For projects of similar nature comparable to the works concerned will be accepted works for repair and/or reconstruction and/or restoration and/or conservation of original and/or stone walls of immovable cultural heritage / monuments of culture. The discrepancy between the above stated criteria and the text on Page 9 of the Instructions to tenders will be corrected and published on the Bulgaria-Serbia IPA Cross – Border programme official website <http://www.ipacbc-bgrs.eu/tenders> as well as on the municipal website at <http://www.montana.bg/общинска-администрация/обществени-поръчки>.

In this regard the answers to the asked questions are as follows:

1. The tenderer must have completed at least 2 (two) projects of the same nature as the works concerned by the tender and implemented during the following period: 28.04.2009 ÷ 28.04.2017.
2. The tenderer should present evidence of relevant experience in carrying out works of a similar nature, including the nature and value of the contracts, works in hand and contractually committed (Form 4.6.4). The evidence must include successful experience as the prime contractor in construction of at least 2 (two) projects of the same nature and complexity comparable to the works concerned by the tender during the last 8 (eight) years;
