

## JOINT MONITORING COMMITTEE

meeting under Interreg-IPA CBC Bulgaria - Serbia Programme held on 26 November 2018, Pirot, Serbia

## 1. Description:

The Joint Monitoring Committee meeting under Interreg-IPA CBC Bulgaria-Serbia Programme was held on 26 November 2018, in Pirot, Republic of Serbia, with the following agenda:

## 2. Decisions:

The following decisions were taken by the Joint Monitoring Committee:

- The JMC approved the lists of 41 projects to be financed under the three Priority Axes as follows:
- 1.1. CB007.2.32.209. Contracts could initially be concluded with the 10 projects with the highest score within available budget, and in case of amendment of the Programme and re-allocation of funds from Priority Axes 1 and 2 to Priority Axis 3 - with the remaining 7 projects.

JMC approved the project proposals received at least 65 points at the 2. technical and quality assessment, for which funding is unavailable, to

be placed in the reserve lists.

JMC approved giving the mandate to the Managing Authority for 3 negotiations with the provisionally approved projects in order to establish the final amount to be contracted under each project and to

present the results to the JMC for final approval.

JMC approved giving the mandate to the Managing Authority after 4. completion of the pre-contracting procedures to initiate a procedure for amendment of the Programme, concerning re-allocation of funds from Priority Axes 1 and 2 to Priority Axis 3, based on the amount of generated savings after signature of the contracts under the current Call for Proposals.

The hereby Decision enters into force on 26 November 2018 - the date of the JMC meeting.
