

JOINT MONITORING COMMITTEE
under Interreg-IPA CBC Bulgaria - Serbia Programme
Written procedure No. 63, initiated on 31 May 2022

1. Description:

The Written procedure for approval of the proposal for further financing of projects from the reserve list under the Second Call for Proposals under the Interreg-IPA CBC Bulgaria - Serbia Programme 2014-2020, was initiated by the Deputy Minister of Regional development and Public Works of the Republic of Bulgaria and Co-chairperson of the JMC on 31.05.2022.

The proposal includes two project proposals under Priority Axis 1, "Sustainable Tourism", four project proposals under Priority Axis 2 „Youths“, and two project proposal under Priority Axis 3, "Environment". The total amount of the eight projects is 1 102 197,67 euro.

The official letter No. 99-00-2-108/30.05.2022 with the proposed project proposals for financing from the reserve list, was sent to the JMC members via the Management Information System of the Programme, for review and approval.

The JMC members were given 5 working days to send their approval or comments on the proposed documents. No rejections were received.

2. Decisions:

JMC approves the proposed for further financing project proposals from the reserve list under the Second Call, as follows:

- CB007.2.12.020 with Lead partner - Municipality of Zemen and budget of 184 000,14 euro;
- CB007.2.12.070 with Lead partner - No Frontiers 21 Century Association and budget of 199 999,87 euro;
- CB007.2.22.128 with Lead partner - Association "Institute for Territorial Innovations and Cooperation – ITIC" and budget of 144 756,88 euro;
- CB007.2.22.162 with Lead partner - Community Center "Geo Milev - 1954" and budget of 144 054,02 euro;
- CB007.2.22.220 with Lead partner - Ministry of Health, Republic of Bulgaria and budget of 149 582,76 euro;
- CB007.2.22.228 with Lead partner - Association "Youth Municipal Council" and budget of 135 094,00 euro;
- CB007.2.32.066 with Lead partner - The Timok Club and budget of 105 671,89 euro;
- CB007.2.32.046 with Lead partner Vidin Chamber of Commerce and Industry and budget of 165 475,55 euro

and gives mandate to the Managing bodies to conduct pre-contracting procedures with them.

The hereby Decision enters into force on 7 June 2022 - the date following the deadline for submission of objections / additional proposals from the JMC members.
